1. RULES

- 1.1 This series will be governed by the rules as defined in the *Racing Rules of Sailing (RRS)*.
- 1.2 US Sailing Prescription, RRS 82 will not apply.

2. ELIGIBILITY AND ENTRY

- 2.1 This series is open to Star Class boats.
- 2.2 Eligible boats may enter a single race or the entire series by completing online registration at the [Starlight Series](#) webpage and paying all fees prior to 1645 on the day of the race. An entry is not complete until payment is received. .

3. FEES

The series entry fee is \$60 for US Sailing members with proof of membership, \$70 for non-members. The entry fee for individual races is \$10 for US Sailing members and \$12 for non-members.

4. SCHEDULE

- 4.1 Races are scheduled each Thursday evening from May 9 through August 15, with the exceptions of May 23 and July 4, for a total of 13 evenings.
- 4.2 The scheduled time of the first warning signal each evening will be no earlier than 1757, with up to four (4) races scheduled. The Race Committee, at its discretion, may run fewer races.

5. SAILING INSTRUCTIONS

The Sailing Instructions (SI) will be posted at the [Starlight Series](#) webpage by Sunday, May 5.

6. VENUE

The racing area will be on Santa Monica Bay approximately 0.25 nautical miles northwest of the Marina del Rey breakwater.

7. COURSES

Courses will be a windward / leeward format.

8. SCORING

- 8.1 All race scores each evening will count.
- 8.2 The series will be scored using a modified High Point System, counting each boat's final standing from each evening as a single score, excluding, at maximum, her worst two (2) final standings. Details on the High Point System will be provided in the SI.

9. PRIZES

Trophies for each evening will be awarded at CYC as soon as possible after racing.

10. DISCLAIMER OF LIABILITY

Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. By participating in this event, each competitor agrees to release the race organizers (organizing authority, host yacht club, race committee, protest committee, sponsors, and any others acting in an official capacity for this event) from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
