NOTICE OF RACE

GENERAL INFORMATION

1. RULES

- 1.1 The event is governed by the rules as defined in <u>The Racing Rules of Sailing</u> (RRS).
- 1.2 PHRF of Southern California (PHRF SoCal) Class Rules are in effect for handicap boats.
- 1.3 The second sentence of RRS 78.2 is deleted and replaced with "The boat shall produce the certificate or arrange for its existence to be verified by the race committee (RC) by the entry deadline specified in NOR 5.3."
- 1.4 US Sailing Prescription RRS 81 does not apply.
- 1.5 [DP] While racing, all boats shall
 - (a) display the class flag assigned for their class, and
 - (b) have official sail numbers on their mainsail and any overlapping headsails. Competitors are reminded that RRS G1.2 states that sail numbers shall be "Arabic numerals" and "clearly legible".

2. SAILING INSTRUCTIONS

The Sailing Instructions (SIs) will be posted by 1900 on Wednesday, April 28 on the Official Notice Board.

3. COMMUNICATION

- 3.1 The Official Notice Board is the Before Sunset webpage.
- 3.2 [DP] All boats shall carry a VHF radio capable of communicating on normal domestic and international channels.
- On the water, the Race Committee (RC) may make courtesy broadcasts to competitors on VHF radio, including starting penalties. The channel will be stated in the SIs.
- 3.4 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. CODE OF CONDUCT

- 4.1 [DP] Each race entrant and skipper is responsible for ensuring that all members of their crew, support personnel and their guests abide by the laws, public health orders, and guidance from government authorities and/or CYC applicable to sailing and/or shore side activities in effect during the event to minimize potential exposure or transmission of the COVID-19 virus.
- 4.2 A link to the Los Angeles County Department of Public Health guidelines for recreational boating and public gatherings will be posted on the Official Notice Board as soon as it is available.
- 4.3 Failure to comply with NoR 4.1 may be misconduct.
- 4.4 Reasonable actions by event officials and CYC to implement COVID-19 guidance, protocols or legislation, even if they later prove to have been unnecessary, are not improper actions or omissions.

5. ELIGIBILITY AND ENTRY

- 5.1 The event is open to keelboats with a maximum length overall of fifty-five (55) feet that have a valid PHRF SoCal Rating Certificate, and to Martin 242 Class boats. Other one-design classes may petition the OA for inclusion.
- 5.2 Eligible boats may enter by completing online registration and paying the required fees at the link on the Official Notice Board.
- To be considered an entry in a race, a boat shall complete all registration requirements and pay the required fees by the entry deadline of 1730 on the day of that race.
- 5.4 For competitors under the age of eighteen (18), a parent or guardian must accept the Waiver of Liability during online registration.

6. DIVISIONS / CLASSES

- 6.1 Boats will compete in either the Performance or the Cruising Division.
- 6.2 The Performance Division will include one-design classes, and handicap boats that compete with a rating that does not include any Configuration Adjustments found in Appendix F of the PHRF SoCal Class Rules.
- 6.3 The Cruising Division will include only those boats whose Performance Factor (PF) is ≤ 2 . A boat with a PF > 2 may petition the OA for inclusion in that Division. The OA reserves the right to reassign boats from the Cruising Division to the Performance Division.
- 6.4 Classes will be established within each Division at the discretion of the OA.
- 6.5 Classes, class flags and starting times will be posted by 1900 on Wednesday, April 28 on the Official Notice Board.

7. FEES

The entry fee is \$5 per race.

8. SCHEDULE

One race is scheduled for each Wednesday night from May 5 to May 19. Each race is considered an individual event.

9. VENUE

The racing area will be on Santa Monica Bay and inside Marina del Rey Harbor.

COURSES

Boats will start outside the Harbor at MDR Mark SS (see Marina del Rey Course Chart 17), go to a windward mark, and finish inside the Harbor.

11. SCORING

- 11.1 Each race will be scored as an individual event.
- 11.2 Handicap boats will be scored using their valid PHRF SoCal Area B W/L ratings. Boats from outside Area B will have Area B adjustments applied as available.
- 11.3 Non-spinnaker offsets will be used in the Cruising Division only. To have this applied, a boat must declare to be "non-spinnaker" when registering. The PHRF SoCal Area B W/L rating for a boat so declaring will be adjusted by +9 sec/mi if competing in Cruising A, and +7 sec/mi if competing in Cruising B.

12. DISCLAIMER OF LIABILITY

Competitors in the event participate entirely at their own risk. See RRS 3, Decision to Race. By participating in the event, each competitor agrees to release the race organizers (organizing authority, host yacht club, race committee, protest committee, sponsors, and any others acting in an official capacity for the event) from any and all liability associated with such competitor's participation in the event to the fullest extent permitted by law.

13. PRIZES

Award certificates will be emailed to the winning skippers as soon as possible after each race. The number of certificates for a class will be based on the number of starters in the race as follows: 2-4 boats = 1 certificate; 5-7 boats = 2 certificates; 8-10 boats = 3 certificates; 11-13 boats = 4 certificates; 14+ boats = 5 certificates.
