

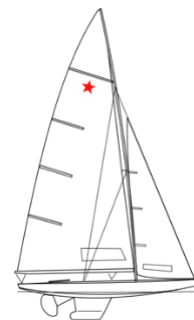

#### GENERAL INFORMATION

The Organizing Authority (OA) is the International Star Class Yacht Racing Association District 5 in conjunction with California Yacht Club (CYC). CYC is located at 4469 Admiralty Way, Marina del Rey, CA 90292

#### 1. CHANGES TO SAILING INSTRUCTIONS

Any change to the Sailing Instructions (SIs) will be posted before 0930 on the day it will take effect.

#### 2. COMMUNICATIONS WITH COMPETITORS

2.1 Notices to competitors will be posted on the Official Notice Board which is the [King of Spain Regatta](http://www.kingofspainregatta.com) webpage. Notices may also be posted on the bulletin board outside the main entrance to the CYC clubhouse.

2.2 On the water, the Race Committee (RC) intends to monitor and communicate with competitors on VHF radio channel 68. Failure of the RC to broadcast, mistaken broadcasts, or failure of a competitor to receive this information will not be grounds for a request for redress. This change is added to RRS 62.1(a).

2.3 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 3. SIGNALS MADE ASHORE

3.1 Signals made ashore will be displayed on the flagpole located on the CYC front lawn.

3.2 When flag AP is displayed ashore, "1 minute" is replaced with "not less than sixty (60) minutes" in RRS Race Signals AP.

#### 4. SCHEDULE OF RACES

4.1 Six (6) races are scheduled: three (3) on Saturday and three (3) on Sunday. The RC, at its discretion, may run fewer races.

4.2 The scheduled time of the first warning signal each day is 1230. Subsequent races will start as soon as practicable.

4.3 The RC may display flag A (with no sound) while boats are finishing to signal that there will be no more races conducted that day.

#### 5. CLASS FLAG

The class flag is a red Star logo on a white background.

#### 6. RACING AREA

The racing area is on Santa Monica Bay with the starting area approximately one (1) nautical mile northwest of the Marina del Rey breakwater.

#### 7. MARKS

Marks are described in SI Addendum A.

#### 8. COURSES

Courses are described in SI Addendum A.

#### 9. THE START

9.1 The starting line is between the staff displaying an orange and white checkered flag on the RC pin-end boat and the staff displaying an orange and white checkered flag on the RC signal boat (see SI Addendum A). This changes RRS Race Signal Orange.

9.2 If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the RC will attempt to hail her sail number as provided in SI 2.2.

9.3 A boat that does not start within ten (10) minutes after her starting signal shall be scored Did Not Start (DNS) without a hearing. This change is added to RRS A5.1.

## 10. CHANGING THE NEXT LEG OF THE COURSE

To change the next leg of the course, the RC will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced with the original mark.

## 11. THE FINISH

The finishing line is between **the staff displaying an orange and white checkered flag on the RC pin-end boat** and the staff displaying an orange and white checkered flag on the RC signal boat (see SI Addendum A). This changes RRS Race Signal Blue.

## 12. PENALTY SYSTEM

RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

## 13. TIME LIMITS

13.1 The Mark 1 Time Limit and Race Time Limit (see RRS 35) are shown in the table below in minutes.

Mark 1 Time Limit	Race Time Limit
30	120

13.2 The target time for each race is 60 minutes. Failure to meet the target time will not be grounds for a request for redress. This change is added to RRS 62.1(a).

13.3 If no boat has passed the first mark within the Mark 1 Time Limit, the race will be abandoned.

13.4 Boats failing to finish within the Race Time Limit, and not subsequently retiring, penalized, or given redress, will be scored Time Limit Expired (TLE) without a hearing. A boat scored TLE shall be scored points for the finishing place one (1) more than the points scored by the last boat that finished within the Race Time Limit. This changes RRS 35 and is added to RRS A5.1, 5.2 and A10.

## 14. HEARING REQUESTS

14.1 The protest time limit each day is forty-five (45) minutes after the RC signal boat docks on that day. This time will be posted at the *Protest Time Limit and Hearing Schedule* link located on the [King of Spain Regatta](#) webpage no later than fifteen (15) minutes after the RC signal boat docks.

14.2 RRS 62.2, Redress is modified as follows:

14.2.1 The second sentence of RRS 62.2 is replaced with: "If the request is based on an incident in the racing area, it shall be filed within the protest time limit for that day."

14.2.2 A notice of boats scored per RRS A5.1 each day will be posted at the *View Starting Penalties* link located on the [King of Spain Regatta](#) webpage no later than fifteen (15) minutes after the RC signal boat docks on that day. The deadline for a request for redress based on these scores is the protest time limit for that day.

14.2.3 The time limit for a request for redress based on a scoring inquiry (see SI 15.2) is 30 minutes after the results of the scoring inquiry have been posted.

14.3 Hearing request forms are available at the *File a Protest* link located on the [King of Spain Regatta](#) webpage.

14.4 Notices will be posted no later than fifteen (15) minutes after the protest time limit each day at the *Protest Time Limit and Hearing Schedule* link located on the [King of Spain Regatta](#) webpage to inform competitors of hearings in which they are parties. Hearings will be heard as soon as possible in the Gallery Room on the lower level of the CYC clubhouse.

14.5 US Sailing Prescriptions to RRS 63.1 and 63.2 do not apply.

## 15. SCORING

15.1 Preliminary results will be posted on the [King of Spain Regatta](#) webpage as soon as possible after racing each day.

15.2 Competitors shall notify the RC of any scoring errors using the *Submit Scoring Inquiry* link on the [King of Spain Regatta](#) webpage. The deadline to file a scoring inquiry is the protest time limit or thirty (30) minutes after the preliminary results have been posted for that day, whichever is later.

## 16. SAFETY REGULATIONS

16.1 Prior to the warning signal for the first start each day, when the RC signal boat is displaying Code Flag "L", each competitor shall sail past the stern of the RC signal boat, hail her sail number, and be recognized by the RC. Boats missing their first race may check in upon arrival at the Racing Area. Any boat failing to check-in properly may be given a twenty percent (20%) scoring penalty applied without a hearing to that boat's first valid race of the day. This change is added to RRS A5.1.

16.2 [DP] A boat that retires from a race prior to finishing or does not intend to start a scheduled race shall notify the RC either before leaving the racing area or as soon as possible after arriving ashore.

**17. [DP] SUPPORT TEAMS**

- 17.1 All SPVs shall carry and monitor a VHF radio capable of communicating on normal domestic and international channels.
- 17.2 SPVs shall not enter the racing area from the preparatory signal of a race until the finish of the last boat in that race. However, SPVs may enter the racing area at the direction of the RC to assist a competitor or after a general recall, abandonment or postponement until a new preparatory signal has been made. The racing area shall be as indicated on SI Addendum A and include any other area within one hundred (100) meters of any boat still racing.
- 17.3 SPVs shall neither create wakes nor otherwise interfere with competitors.
- 17.4 SPVs and spectator boats shall not be launched or recovered at CYC while competitors are launching or recovering their boats and must check in with the CYC Dockmaster, [Chase Young](#) (310.823.4567) prior to using the hoist. Alternately, boats may use the public ramp at Dock 52 on Fiji Way and keep the trailers at CYC.

**18. PRIZES**

Health guidelines permitting, the awards ceremony will be held at CYC after racing on Sunday.

**19. RISK STATEMENT**

Competitors participate in the event entirely at their own risk. See RRS 3, Decision to Race. By participating in the event, each competitor agrees to release the race organizers (organizing authority, host yacht club, race committee, protest committee, sponsors, and any others acting in an official capacity for the event) from any and all liability associated with such competitor's participation in the event to the fullest extent permitted by law.

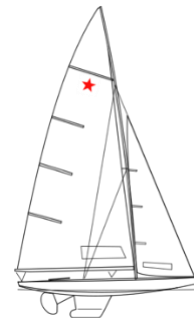

### SI ADDENDUM A

**SI 7. MARKS** (continued)

- 7.1 Mark 1 is an orange or yellow tetrahedron whose color is signaled per SI 7.2.
- 7.2 The color of Mark 1 is indicated during the starting sequence by an orange or yellow pennant displayed on the RC signal boat.
- 7.3 A new windward mark, as provided in SI 10, is the alternate color to the one signaled during the starting sequence.
- 7.4 Mark 1a (offset mark) is a small orange tetrahedron with a black band.
- 7.5 Mark 2s/2p are yellow tetrahedrons.
- 7.6 ~~Mark S is an orange tetrahedron.~~

**SI 8. COURSES** (continued)

- 8.1 Marks 1 and 1a shall be rounded to port.
- 8.2 The angle between the leg from the starting line to Mark 1 and the leg from Mark 1 to Mark 1a is approximately 90°.
- 8.3 Mark 2s/2p is a gate. In the event only one gate mark is on station, that mark shall be rounded to port.
- 8.4 The starting/finishing line is approximately 0.1 nautical mile to leeward of Mark 2s/2p.
- 8.5 No later than the warning signal for each race, the RC signal boat will use numeral placards to display the approximate magnetic bearing and distance from Mark 2s/2p to the first weather mark.
- 8.6 The course as described in STCR 34.3.6 and shown below will be used for all races.
